Those are the things I have taken away from my work with Rhonda these past two years, and I don't mind writing here that I think she has been a paradigm-shifting officer who has set a high bar for her successors (and not just secretary-treasurers). I am grateful for what she has taught me, and I hope I can apply those lessons as we continue to work on behalf of all staff. Thank you, Rhonda, for exemplifying what a senate officer should be, and for all your support.

As we pass officer elections today, I also want to give special thanks to John Smith, who has also been a friend and mentor, helping me become a better officer and person over the past two years; to Virginia Hosono, Jason Beare, and Melissa Taylor, who chair the three committees that default to the VC, and who have each done such an impressive job in their roles; to Leondra Gully, for her work with me on the anti-racism *ad hoc* committee, and for carrying that torch forward with CARE; to Angela Lewis-Klein, Ginger Brown, and the incomparable Glenn Gittings, for their support at various points along the way; and to Will Adamchik, who inspired me to get involved with senate in the first place.
