Last month I told you there were two things of particular importance taking place. One, the ongoing presidential search and two, the athletic director search. I am happy that the athletic director search has been completed. Not only that it has been completed, but more so in the person we have selected to be our athletic director. Here is some information on the presidential search.

Presidential Search: I am excited that we are moving onto the part of the process that will start generating candidates. There is a very good website dedicated to the search. https://louisville.edu/presidential-search I encourage you to visit the site and spend some time going through it. We are trying to be as transparent as possible with the entire process but the candidates themselves will be very confidential. All 13 of the search firms we reviewed told us if that were not the case, our candidate pool would be greatly diminished. The very best candidates will not jeopardize their capital in their current setting and thus would not allow their name to go forward if that were not the case. The site contains the Leadership Profile, which is the informational piece all potential candidates review before deciding whether to pursue the position or not. For many searches, this document is not available publicly as it is with us. That document is twenty something pages long and gives a lot of detailed information about who we desire for this position. There is a link where you may nominate a candidate. Every candidate nominated will be vetted by the search firm, WittKieffer, and strongly considered. There is a page listing all communications that have been released, a page for events revolving around the search and information on the three members of the WittKiefer team that are working directly with us.

I am a member of the search committee that will bring a final candidate to the full Board of Trustees for approval. Please never hesitate to reach out to me at any time during the search process with any questions or comments.

I am including our ideal schedule below for informational purposes only. Please know though, we are committed to identifying the best possible candidates for

this search and are willing to modify the schedule in the best interest of the University of Louisville if that will assist in that process. ie, this would be viewed as the aggressive version of the search. We may very well complete the process on this schedule but are willing to extend it if would be beneficial to do so.
